Levelized Natural Gas Budget Will Begin On The **JULY 1st** Utility Bill.

I agree to pay the calculated monthly levelized budget amount instead of the charges for the actual Natural Gas Usage.

### **Please Remember:**

- The Commission reserves the right to re-adjust the budget amount any time deemed necessary.
- Meter Readings will still be obtained.
- Late Charges apply.
- Still Subject to disconnection for non-payment, at which time the entire balance will be due before service is restored.
- By June 10th of every year all budget amounts shall be brought to a zero balance unless a customer has a credit balance, which will carry over to the next month's bill.
- Once a year during the month of April the Utility Office will post a notice reminding customers of the budget plan. All customers interested must pay all current balances by June 10th.
- All equity balances are refundable if the customer ceases to be a utility customer.

NATURAL GAS BUDGET PAYMENT PLAN AGREEMENT

This agreement made in duplicate between the GRAYSON UTILITIES COMMISSION, with its office located at 671 South State Highway 7, Grayson, Kentucky 41143. (hereinafter called the "Commission") and \_\_\_\_\_ (hereinafter called the "Customer") Account Number \_\_\_\_\_ located at \_\_\_\_\_.

WITNESSETH: In consideration of the Customer's request to make Natural Gas service payments under the Commission's Natural Gas Budget Payment Plan, the Customer shall pay the Commission at a fixed amount each month in lieu of monthly billings based on actual usage. Where by, any difference in the actual amount due and the fixed amount paid each month shall be payable in full each year in the month of June 10th, one year from the beginning date of the Budget Amount.

It is further agreed:

1. The Customer agrees that the monthly budget payments are subject to change where a trend develops indicating the amount set up is insufficient to result in reasonable balance due on June 10th; at which time the difference in the fixed amount and the actual costs of the natural gas service is payable in full.
2. It is agreed that the Customer shall make payment each month in full amount of the Budget Payment as stated herein, regardless of any accumulated charges or credits for actual usage. Should the Customer fail to make such budget payments by the due date, service will be discontinued and the entire balance becomes due and payable before service is restored this Customer shall be ineligible for future billings under the Budget Payment Plan.
3. This agreement shall continue from year to year, unless terminated by either party giving to the other notice in writing, subject to the provision stated in number 2 above.

THEREUPON, it is agreed that \_\_\_\_\_ (Customer) shall pay to the Grayson Utilities Commission each month, beginning with the July 1<sup>st</sup> Utility billing, for gas service in the amount of \$\_\_\_\_\_ under the Natural Gas Budget Payment Plan Agreement. Customer shall also pay in full annually the balance resulting from difference in actual usage and fixed amount paid each month on the June 1st billing. If a credit balance is determined at that time it will be applied automatically on the succeeding months bill.
